DFG: International Cooperation – Standing Open Proposal Submission in Individual Grants Programme / No Deadline

DFG-Förderung für transnationale Forschungsprojekte mit europäischen und internationalen Partnern

The German Research Foundation (DFG) supports transnational research collaboration through agreements with multiple funding organizations in Europe and worldwide. In addition to fixed-deadline calls, some agreements allow for **Standing Open Procedures**, where proposals can be

submitted at any time. **European** partners include Austria (FWF), Belgium (FWO, F.R.S.-FNRS), Czech Republic (GACR), Luxembourg (FNR), Poland (NCN), and Switzerland (SNSF), with a bilateral Lead Agency agreement in South Tyrol (Italy). **Worldwide**, the DFG cooperates with Brazil (FAPESP), Colombia (UNIANDES, UdeA), India (ICSSR), Turkey (TÜBITAK), and the USA (NSF in selected fields). Applications follow parallel submission procedures, with evaluations conducted independently by both funding agencies. Funding is granted only to proposals positively reviewed by both sides. #### EU: CERV Funding Calls 2025 – Rights, Participation, and European Values

CERV Förderaufrufe 2025 im Bereich Bürger, Gleichheit, Rechte und Werte

The Citizens, Equality, Rights and Values (CERV) program has launched multiple funding calls in 2025 to support projects promoting children's rights, democratic participation, historical remembrance, and fundamental rights across the EU.

- Children's Rights and Participation (Deadline: 29.04.2025) Supports initiatives that protect and enhance children's rights, particularly in the digital environment, while fostering active participation in society. Special focus is given to vulnerable children, including those affected by conflicts such as the war in Ukraine.
- Citizens' Engagement and Participation (Deadline: 29.04.2025) Funds projects that strengthen civic engagement and democratic participation, counter disinformation, and promote discussions on EU policy priorities, with a focus on young and older people, women, mobile EU citizens, and people with disabilities.
- **European Remembrance (Deadline: 17.06.2025)** Supports projects that raise awareness of key historical moments in European history, including authoritarian regimes, slavery, colonialism, and the Holocaust, while fostering reflection on shared European values.
- Fundamental Rights and Rule of Law (Deadline: 18.09.2025) Promotes initiatives that increase awareness of the EU Charter of Fundamental Rights, combat hate crime, protect human rights defenders, and reinforce democratic values and civil society.

Centres enable particularly distinguished researchers to collaborate for the purposes of further developing a research topic in the humanities and social sciences in a certain location. The aim here is to tackle a topic so broadly defined that it ties into existing interests and strengths at the site, while remaining capable of providing a framework for the integration of different individual research concepts. The key characteristics are intensive independent research usually performed by 2-3 responsible researchers – where applicable, made possible through leave of absence – and a fellow programme for visiting researchers from Germany and abroad. <u>Further Information</u>. The Fritz Thyssen Foundation supports scholars in the humanities, social sciences, and biomedicine through funding for subject- and time-limited research projects. Applications may be submitted in the following areas: History, Language & Culture and State, Economy & Society. Interdisciplinary projects are also welcome. Funding is reserved for projects with a clear connection to the German research system, either through German researchers, affiliation with a German institution, or thematically relevant studies. Eligible applicants must be based at universities or non-profit research institutions, and projects may be funded for up to three years, with an initial grant of two years and the possibility of extension. The VolkswagenStiftung invites research teams in the humanities, cultural studies, and theoretical social sciences to apply for funding under the Open Up initiative. The program supports projects that explore new and original research spaces, encouraging multi-perspective approaches to complex and underexplored topics. Teams of two or three researchers (with the main applicant affiliated with a German university or research institution) can apply for up to €300,000 (two-person teams) or €400,000 (three-person teams) for a period of up to 1.5 years. The selection process includes an anonymized application procedure and Distributed Peer Review. The Change Fellowships program by the Volkswagen Stiftung supports postdocs and junior professors from all disciplines who have completed their doctorate at least two years ago. The program enables researchers to conduct transdisciplinary research with a strong practical focus, addressing societal challenges and initiating transformation processes. Collaboration with non-academic partners (e.g., NGOs, associations, public authorities, small businesses) is mandatory. The funding amounts to €1.5−1.8 million for a duration of 4−5 years. Fellows are expected to develop and present a transatlantic project, demonstrating strong English proficiency and a commitment to interdisciplinary exchange. DFG: Support for Refugee Researchers / No Deadline

Fördermöglichkeiten für geflüchtete Wissenschaftler:innen in Deutschland

The German Research Foundation (DFG) continues to support researchers who have fled their home countries, facilitating their integration into the German research system. Eligible scholars with a PhD who have left their home country within the last three years can apply for a Walter Benjamin Fellowship, allowing them to conduct an independent research project with institutional career support. For this target group, the usual focus of the program on early postdoctoral researchers does not apply. Additionally, refugee researchers can be integrated into ongoing DFG-funded projects (e.g., research groups, priority programs, graduate schools) through supplementary funding requests, covering research positions at various career levels. For established researchers, the Mercator Module enables funding for travel, accommodation, and salary costs. The DFG also extends its Ukraine Special Program, allowing Ukrainian researchers in Ukraine to receive financial support for project implementation, including a monthly stipend of up to €1,000 per project leader. #### VolkswagenStiftung: 10,000 Euro for Reviewers

The VolkswagenStiftung continues its funding experiment to recognize the crucial role of reviewers in the peer review process. Researchers who complete a review for the foundation by 31 December 2025 will automatically be entered into a lottery. 25 reviewers will be randomly

selected to receive €10,000 in dedicated research funding, which can be used for academic purposes such as conference travel or organizing international workshops. The fellowship provides a six-month leave after administrative duties, allowing recipients to intensively re-engage with their field, review relevant literature, and explore new research areas. The Fritz Thyssen Foundation funds a temporary replacement for the scholar's teaching obligations during this period and thereby also promotes early-career researchers career perspectives. #### VolkswagenStiftung: 10,000 Euro for Reviewers & Peer Review in Open Up
