DFG fördert internationales Kooperationsprojekt von Sören Carlson New collaboration explores Erasmus+ and transnational class formation / 10.25–09.26

Dr. Sören Carlson (Europa-Universität Flensburg) has received funding from the DFG's Initiation of International Collaboration programme to strengthen a research collaboration with Prof. Karolina Barglowski (Université du Luxembourg), Prof. Irma Budginaitė-Mačkinė (Vilnius University), and Dr. Thais França (ISCTE — University Institute of Lisbon). The project will explore whether and how Erasmus+ functions as a site of transnational class formation. Over the course of 12 months, the team will meet for two workshops in Flensburg and conduct research visits to Lisbon and Luxembourg.

Dr. Sören Carlson (Sociology, Europa-Universität Flensburg), together with J.-Prof. Dr. Daniel Drewski (University of Bamberg), Dr. Zsófia S. Ignácz (Goethe University Frankfurt), and Dr. Susann Worschech (European University Viadrina), has received funding from the Volkswagen Foundation to organise a workshop on 'Europe in flux – implications for the sociology of European integration'. The event will take place at the Foundation's Herrenhausen Conference Centre in Hannover and will bring together scholars from across Europe to critically discuss current challenges and new directions in the sociology of European integration.

Vorabveröffentlichung des Horizon Europe Arbeitsprogramms 2026–27

Democracy, Culture and Transformation in the 2026–27 Draft Work Programme / Deadlines: 16.09.2026 & 16.09.2027

The draft Work Programme 2026–27 for Cluster 2 – *Culture, Creativity and Inclusive Society* – offers a wide range of topics highly relevant to social sciences and humanities (SSH). While the current programme maintains a substantial budget share for dedicated SSH calls, structural changes are expected in the next framework programme from 2028, which may reduce the opportunities of SSH in future funding lines. The 2026–27 calls are organised across three thematic destinations within the calls of 2026 and 2027:

- DEMOCRACY-01: Tackling gender-based violence against politically active women and LGBTIQ people

The German Research Foundation (DFG) invites proposals for the new Priority Programme "Rethinking Disinformation (Re:DIS)" (SPP 2573), which aims to foster interdisciplinary collaboration on conceptual and empirical approaches to disinformation. Projects should address the epistemic impact of disinformation across at least two disciplines (e.g. philosophy, psychology, social and political sciences, computer science, linguistics, or law). With the funding guideline "Diversity connects", the Federal Ministry of Education, Research and Technology Transfer (BMFTR) supports projects and activities that contribute to the structural strengthening of diversity within the science system. The program particularly funds initiatives that promote exchange and networking between interest groups, universities, and research institutions, dismantle barriers, and enhance the participation of underrepresented groups. The aim is to increase the visibility of diverse perspectives, professionalize anti-discrimination efforts,

and thereby sustainably strengthen the innovative capacity and excellence of German science. The EUF Committee for Research and Knowledge Transfer has reinstated the funding line for student assistant (SHK/WHK) support for doctoral and early career researchers, which had been suspended due to budget constraints. Due to limited resources, this programme will be funded at a lower priority than ongoing support lines. Other funding programmes remain unchanged:

ERC introduces changes to evaluation and application formats in 2026 and 2027

Neue Regeln für Antragstellung und Begutachtung bei ERC-Förderlinien

In September 2025, ERC President Maria Leptin outlined significant changes to the ERC evaluation and application process. Starting with the 2026 Work Programme, the structure of Part B2 will be shortened to a 7-page limit, and the feasibility of the proposed research project will be assessed only at the second stage of evaluation. From 2027 onward, the eligibility windows for Starting and Consolidator Grants will be extended.

To reduce workload for evaluation panels, further measures include the removal of mandatory individual comments on applicants in stage one and a new rule allowing panels to omit discussion of proposals that receive low scores (≤ 3.5) from all reviewers.
