ICES Call for field research and qualification grants / Deadline: 15.12.2025 ICES (ko-)finanziert Teilnahme an Methodenschulungen, Feldforschungs- und Archivaufenthalte

We provide grants for researchers in qualification phases at EUF as well as for associated ICES members who plan to conduct field research or archive/library stays. In addition, you can apply for funding to participate in European Studies-specific training courses. We can fund stays for research or qualification purposes of generally up to 1.200 euros each. They should take place in spring semester 2025 or autumn semester 2025/26. Please provide an application (max. 1 page), including a short description of your research project respectively the training program you plan to attend, the necessity for and details about your intended stay, preliminary timeframe, and a budget plan. Applications can be submitted in German or English. We give priority to ICES Research School members when awarding the grants. Please send it to ices@uniflensburg.de by 15.12.2025. The call is published every year in May and November. You can also apply for funding between calls. Applications will then be approved as part of the next call. Visibilizing Normative Regional Historical Multilingualism (ViNoRHM): Ideology, Policy, and Practice Abschlussworkshop des DFG-Projekts vom 13.-14. Januar

Over two days, the workshop will explore how historical multilingualism in regional everyday languages – can be researched and visibilized – and present current research results from the project sub-areas of language ideology, language policy and language practices. The ViNoRHM project combines micro-level case studies of language ideology, policy, and practices using primary texts from official records and little-studied archival material, thereby bringing to the forefront previously invisible or invisibilized languages – and individuals (especially women and the less educated) – in an innovative presentation of the linguistic history of the German-Danish border region in the 19th century. The event is aimed at researchers working in historical multilingualism, linguistics, regional and border studies, as well as the campus community, students,

and all interested parties who are keen to gain exciting insights into ongoing research. The workshop will be held in German and/or English, depending on the presenter's preference. There are no registration fees, but we kindly ask all participants (presenters and attendees) to register by December 31st so we can ensure we have enough coffee and cake! DFG: Call for Franco-German SSH Research Projects

ANR-DFG-Programm für deutsch-französische Kooperationen / Deadline: 05.03.26

To mark its 20th edition, the joint programme of the French Agence Nationale de la Recherche (ANR) and the German Research Foundation (DFG) continues to support integrated Franco-German research projects in the humanities and social sciences. There are no thematic restrictions; however, the programme emphasises strong bilateral cooperation and the added value of bringing together different academic traditions. Proposals by early-career researchers are explicitly encouraged. Applications must be submitted in parallel to both agencies by 13:00 (CET) on 5 March 2026. Deutsch-Englische Förderinitiative in den Geisteswissenschaften

The German Research Foundation (DFG) and the Arts and Humanities Research Council (AHRC, UK) are once again funding seventeen joint projects in the arts and humanities, further strengthening their partnership established in 2018. The scheme follows a discovery-led approach, enabling researchers to develop internationally relevant topics independently and to build sustainable German—UK collaborations. The newly funded projects span a wide range of disciplines, from archaeology, history and law to literary and linguistic studies, musicology, religious studies and philosophy — reflecting the thematic diversity and innovative potential of this bilateral programme. UNAM-DFG 2025/2026: Mexican-German Joint Call for Proposals

Deutsch-mexikanische Projektförderung / Deadline: 25.02.2026

The German Research Foundation (DFG) and the Universidad Nacional Autónoma de México (UNAM) have launched their fourth joint call to fund German—Mexican research projects in all disciplines, including the social sciences and humanities. The initiative aims to bring together competitive researchers from both countries to develop and implement joint projects of outstanding scientific quality. Proposals must be submitted in parallel to DFG (Germany) and UNAM (Mexico), in English, and must be identical on both sides. Funding is available for up to three years; unilateral funding of only one project part is not possible. For German applicants, the call follows the rules of the DFG Research Grants Programme ("Sachbeihilfe"), UNAM applicants apply under PAPIIT. Application deadline (DFG & UNAM): 25 February 2026. Erasmus+ Programme 2026 Now Open for Mobility and Cooperation Projects

The new Erasmus+ calls for 2026 are now open, providing more than EUR 5 billion to support learning mobility and cooperation projects across Europe. The programme aims to fund a wide range of organisations and offer opportunities to more than 1,270,000 participants. Over 100,000 organisations are expected to benefit, including universities, schools, vocational training centres, businesses, and youth and sports organisations. DFG: Ausschreibung für den Auf- und Ausbau von Datenkooperationen zwischen Wirtschaft und Wissenschaft

Strengthening Data Partnerships between Research and the Business Sector / Deadline: 11.03.26

The Deutsche Forschungsgemeinschaft (DFG) is funding projects that establish or expand collaborations between researchers and the business sector in order to address fundamental research questions in the fields of health and mobility using company data. The programme aims to provide researchers with access to real-world data while unlocking innovation potential for businesses. It comprises two phases: a one-year Explore phase (application deadline: 11 March 2026) to prepare cooperation agreements and a data governance framework, followed by a two-year Exploit phase for the research work itself. Funding is provided only to the academic partner, and investment funding is excluded. Applications must be submitted via the DFG's elan portal, with first-time users required to register by 4 March. DFG funding initiative "Global Minds in DFG-Verbünden"

Förderinitiative im Rahmen des BMFTR-Programms 1000-Köpfe-plus/ Deadline 06.03.26

Within the BMFTR programme "1000-Köpfe-plus", the German Research Foundation (DFG) has launched the funding initiative "Global Minds in DFG-Verbünden", targeting Collaborative Research Centres (SFB / SFB-Transregio) and Clusters of Excellence (EXC). The aim is to attract outstanding, experienced researchers currently working abroad to the German research system and to strengthen existing DFG consortia through new perspectives and international expertise. Funding is limited to five years. Two funding modules are available: I. Professur (Professorship) – enables DFG consortia to appoint excellent researchers from abroad to professorships at German universities. II. Mercator Fellow Global – addresses experienced researchers who remain based abroad but are closely integrated into the work of the DFG consortium. Application deadline: 6 March 2026 (via the DFG's elan portal). Applicants who do not yet have an elan account are advised to register at least one week before the deadline. The German Research Foundation (DFG) invites new pre-proposals for Kolleg-Forschungsgruppen in the humanities and social sciences. This funding scheme is tailored to the specific working modes of these disciplines and enables distinguished researchers to collaborate closely on an ambitious humanities or social science research topic. Kolleg-Forschungsgruppen are characterised by intensive research activity of two to three core scholars, who may be (partially) released from other duties. In addition, international fellows can be integrated through a fellowship programme and join the group for one to two years. The maximum funding duration is eight years, and the application procedure is multistage. Interested applicants are advised to seek advice from the DFG Head Office before submitting a pre-proposal. Leo Baeck Fellowship Programme – up to 10 PhD fellowships on German-Jewish history and culture (2026/27)

Studienstiftung des deutschen Volkes vergibt bis zu 10 Fellowships / Deadline: 01.02.2026

The Studienstiftung des deutschen Volkes is awarding up to ten fellowships in the Leo Baeck Fellowship Programme for the academic year 2026/2027. The programme supports PhD projects on German-Jewish history and culture from all epochs and disciplines, in cooperation with the Leo Baeck Institute London and the Leibniz Institute for Jewish History and Culture – Simon Dubnow. The fellowship provides a one-year full scholarship (October 2026 – September 2027) of 1650 EUR per month, plus a 100 EUR research allowance, and additional funding for tuition fees, travel to archives, research institutions, conferences and libraries worldwide, as well as possible support for health insurance and childcare. DFG welcomes GWK agreement on programme allowance

DFG Pressemitteilung | 28. November 2025

The German Research Foundation (DFG) welcomes today's agreement in the Joint Science Conference of the Federal Government and the Länder (GWK) to increase the programme allowance from the current 22 percent to 25 percent as of 2027. Although this increase falls short of the rise to 30 percent that the DFG itself considers urgently necessary, it is nevertheless an important signal for strengthening science in view of the strained public budgets and a first step in the right direction. In the interest of the international competitiveness of the projects it funds and of science in Germany as a whole, the DFG is therefore also prepared to shoulder part of the increase decided today itself – even though

this will entail additional burdens for the actual award of funding. From the DFG's point of view, this makes it all the more important now to continue the Pact for Research and Innovation (PFI) beyond the year 2030. DFG-Newsletter, Dezember 2025.
